NEW PARADE ROUTE

Down S. Chatham Avenue from 4th Street and N. Chatham Avenue. The parade will end at Chandler Concrete, located at 804 S. Chatham Avenue. You can turn around in the Chandler Concrete parking lot if you need to.

LINEUP

IMPORTANT: Pay close attention to lineup instructions. Entrants must arrive to line up by 6:15p.

Share the lineup information with everyone involved in your parade entry.

There is NO parking in the parking lot across from the Fire Department, with the exception of Parade Management and school buses transporting band instruments.

We look forward to having you as a participant in the Siler City Christmas Parade.

There will ONLY be ONE Santa allowed in the parade. Santa is provided by the Chatham Chamber of Commerce. A signed Parade Guidelines and Waiver of Liability/Covenant Not to Sue Agreement must be submitted with your Entry Form.



Parade Entry Fee: \$10.00/per entry

Please mail or deliver your entry fee and entry paperwork by December 6, 2021.

Siler City Christmas Parade – LINEUP INSTRUCTIONS

Share this information with **EVERYONE** involved with your entry.



FLOATS, AUTOS, MOTORCYCLES and TRACTORS (and those associated with floats)

Enter the lineup from US HWY 64. Follow the direction of the arrows, as per the map below.

Turn off HWY 64 onto Cottage Grove Avenue (across from the Highway Patrol Station on HWY 64). Take an immediate right onto Memorial Drive.

At the top of the hill, turn left onto Chatham Avenue and fall into line. **FLOATS** and vehicles and walkers associated with floats will be in the right lane.

AUTOS, TRACTORS AND MOTORCYCLES will be in the left lane unless they are associated with a float.

The nose of the first float or auto should be stopped at East 4th Street and North Chatham Avenue while waiting for the parade to take off.

BANDS and WALKERS (associated with a float or vehicle)

Line up in the upper **NORTH end** of the parking lot across from the Fire Department. Stay with your group at all times.

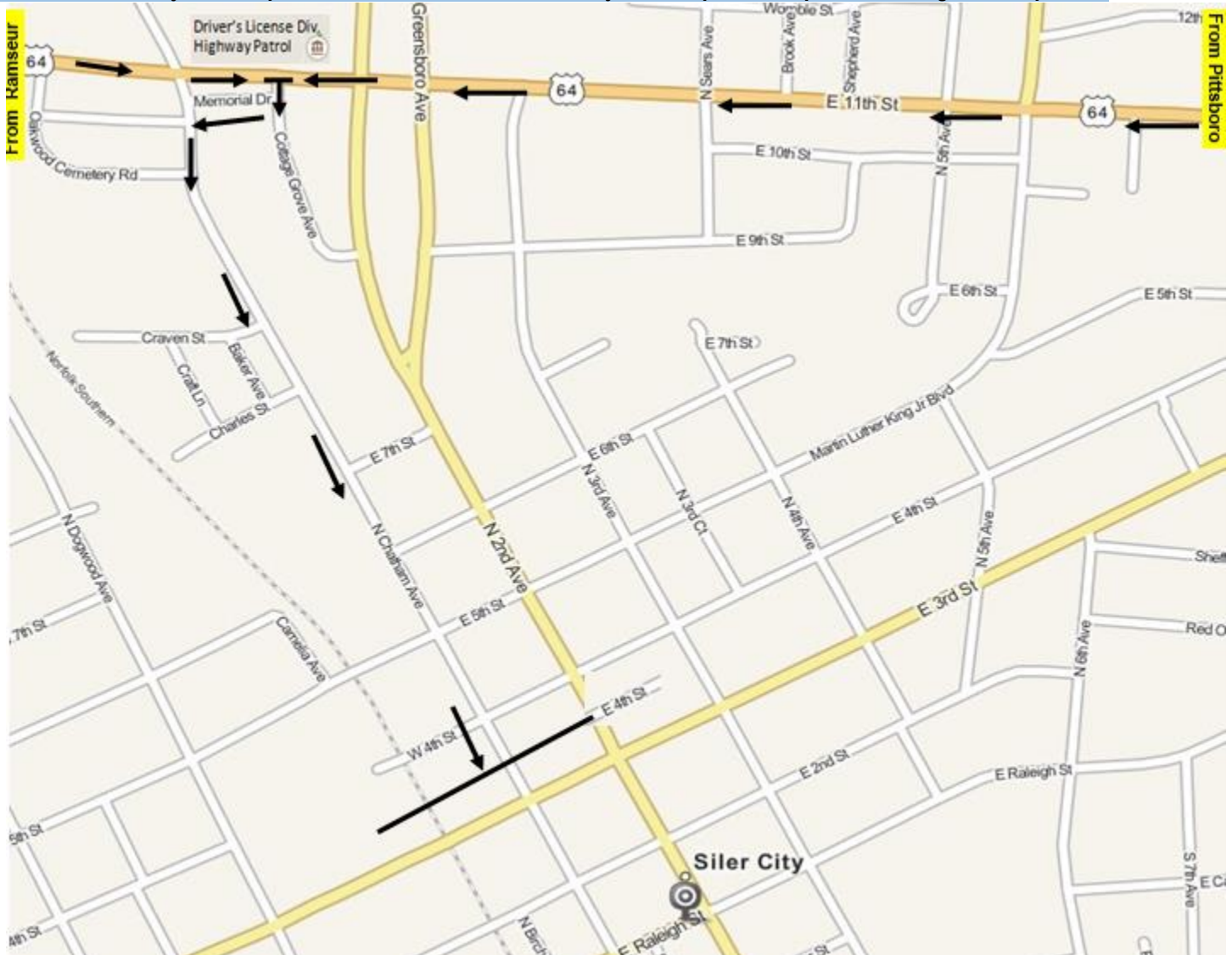
EMERGENCY VEHICLES (not associated with a float or vehicle)

Line up at the Fire Department or at the **SOUTH** end of the lot across from the Fire Department. Arrive at your lineup location via 4th Street.

NO ONE IS ALLOWED TO PARK in the PARKING LOT across from the Fire Department with the exception of parade management and school buses transporting band instruments.

If you have questions on the night of the parade, please ask someone in an orange vest, a Chatham Chamber of Commerce representative with a Santa or elf hat or the Siler City Police Department.

Please be aware of your lineup location and the correct route to your lineup location prior to the night of the parade.

PARADE GUIDELINES *Share these guidelines with EVERYONE associated with your entry.*

Date: Thursday, December 9, 2021
Theme: Christmas Memories
Time: No later than 6:15p for lineup. Parade begins to flow at 7p.



1. **Please read through the Siler City Christmas Parade Guidelines thoroughly before signing below.**
2. You must have a **"Parade Entrant Identification"** attached to your parade entry. You will need to get this identification from the Chatham Chamber of Commerce no later than December 06, 2021.
3. Candy is **not** to be thrown from vehicles. Walkers may walk the route beside or behind their vehicle or float and hand out candy to spectators. We want children and others to be safe at all times.
4. Only "ONE" Santa is allowed in the parade. This Santa is provided by the Chatham Chamber of Commerce.
5. NO ATV's or four wheelers are allowed in the parade.
6. Float and auto riders are to remain on their floats or in their vehicles through the entire route of the parade and should be secured to prevent injury.
7. Horses are not allowed in the parade due to sanitation control.
8. Parade Entrants are responsible for the safety of **ALL** participants involved in their parade entry.
9. Parade entrants (organizations/individuals) assume full responsibility for any loss, damage or injury to **ALL** participants and property involved in their entry.
10. City and county officials are to provide signage for their vehicles.
11. Cats and dogs must be on some form of restraint.
12. There will be zero tolerance for reckless or dangerous driving during lineup or in the parade route.
13. No alcoholic beverages will be allowed.
14. Parking of entrant vehicles and those associated with an entry is prohibited in the lot across from the Fire Department. **This lot is used ONLY for lineup of walkers, bands, emergency vehicles, and parade management.**
15. Emergency Vehicles, Walkers and Bands (not associated with a float) – Be cautious around buildings or other items parked in the lot across from the Fire Department. You will be liable for any damage caused by you or anyone associated with your group.
16. Entrants must have a sign listing the name of their organization on *both sides* of their float/vehicle.
17. If you enter an antique car or truck, please have a sign that lists the make and model of the vehicle.
18. *Follow the Lineup Instructions (attached). Be aware of your lineup location prior to the night of the parade and share this information with drivers and others associated with your entry.*
19. Safety must be a priority of all parade entrants.
20. Retain a copy of the Parade Guidelines and share them with all that are associated with your entry.

I have read through the Siler City Christmas Parade Guidelines in its entirety, said Guidelines being incorporated by reference as if fully set forth herein. I understand and agree that I and anyone involved in my entry will comply with ALL regulations / guidelines.
